Valley View School, Lakhimpur, a co-educational English Medium School made its humble beginning in January, 2013 under the aegis of FOR ALL IN THE HUMANITY (FAITH) a non-proprietary organisation registered under the Registration of Societies Act,1860 with a promise of dynamic, innovative and interesting process of teaching and learning. The school tries to impart to the students the relevance of what they are learning. In the days of digital learning the classrooms are equipped with Smart Boards to facilitate the students with modern tecnology in a stimulating environment conducive for learning.

The School believes in the overall development of a child. So, it lays stress on developing and encouraging sports, art, cultural values and other extra-curricular activities. It tries to instil a lifelong desire for knowledge and learning in every child.

The School follows the NCERT based curriculum and the school is affiliated to CBSE, New Delhi.

Admission to Valley View School is a privilege and not a right. The Principal reserves the right to accept or reject any application for admission without assigning any reason whatsoever.

Recommendations for admission from any source will disqualify a prospective candidate. Parents are therefore, advised to approach the Principal's Office personally for admission and not through any other person or persons.

For a child who has been to school previously and is attending this school for the first time, a Transfer Certificate is to be submitted for class - XI, migration certificate is to be submitted. If the student is from another board, other than CBSE Board, Certificate from the previous School must be furnished before joining School. For those coming from outside Assam, the Transfer Certificate must be countersigned by the appropriate education authority of the state concered. However, this does not apply to CBSE schools. Since no change can be made in the age once it is entered in the Admission Register, a certified copy of the Date of Birth Certificate (DOB) along with the original is also to be submitted. The original will be returned after verification. Please be noted that tampering with T.C. and DOB Certificates will automatically result in disqualification.

Admissions, where vacancies exist, are made on the basis of an entrance examination/ interview (Class V and above). Children who are registered for admission will be notified for the date of the examination and after interacting with child and guardian/parents. The Principal reserves the right to admit the child into the class, deemed suitable for his/her admission. Preference in admission is given to state/central government transfer cases, wards of defense/police forces, wards of parents in the teaching profession and to those children who can be guided at home by concerned parents.

Registration to Valley View School may be closed at any time at the discretion of the Principal.



#### FEES :

- There will be no refund of fees if the ward is withdrawn from the school for what so ever reason.

- □ Any delay in payment of fees will entail 18% interest per annum.
